I understand that the execution of this Agreement is a requirement and pre-requisite for my registration and attendance in the Yoga Child Teacher Training program in which I am enrolling.

The purpose of this agreement is to protect the business interests of Yoga Child and its teaching staff while also outlining the parameters for successfully teaching the Yoga Child curriculum once you have completed your training.

I understand that signing this agreement does not preclude me from teaching the Yoga Child program in school settings or Yoga centers, and that I may teach in such settings, and that Yoga Child encourages me to do so. I further understand that if I wish to teach yoga and mindfulness in settings where Yoga Child currently provides its services, or has provided services in the five years that pre-date my application for work at that particular site, that I must apply to do so through Yoga Child Incorporated. (A complete list of Yoga Child sites is available upon request.) I further agree not to teach yoga and mindfulness classes in locations where Yoga Child is currently in communication or negotiations with the school or other facility regarding a potential teaching contract as I understand this would interfere with the business interests of Yoga Child and its teaching staff. I understand that if I would like to teach in any of these particular sites, I can apply to do so through Yoga Child Inc., as a Yoga Child Instructor. I understand that in order to teach on behalf of Yoga Child, I must complete the Level II Yoga Child Training/Apprenticeship program (unless participation in this level is waived due to my experience), as this will allow me to become eligible for a teaching position through Yoga Child and to become a member of the Yoga Child teaching staff, should positions be available.

I understand that signing this non-compete agreement does not preclude me from teaching the Yoga Child program in any schools, camps or community centers where Yoga Child does not currently teach, so long as Yoga Child has not taught yoga there for the past five years, and that I may teach in such settings and that Yoga Child encourages me to do so. (Yes, please go teach, and share the joy!)

I understand that I may not use the materials and teachings from this program as part of or in order to design or teach my own children's yoga teacher training program.

FOR TEACHERS CURRENTLY WORKING IN SCHOOLS IN WHICH YOGA CHILD HAS CONTRACTS OR PROSPECTIVE CONTRACTS:
It is understood and agreed upon that signing this agreement will not preclude such a trainee from teaching the Yoga Child curriculum in schools in which such a trainee is employed at the time of signing this contract. Please list any such schools here:
